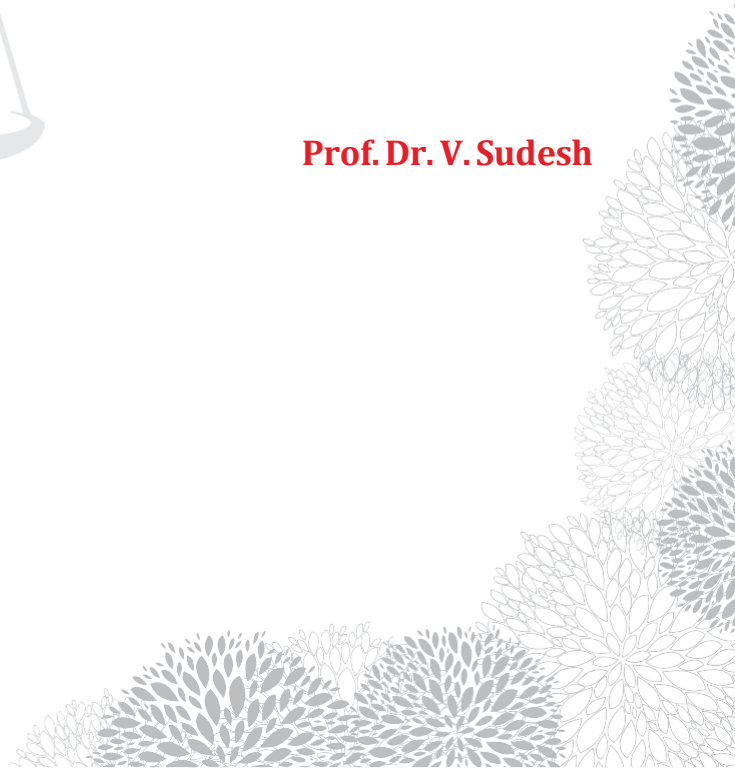
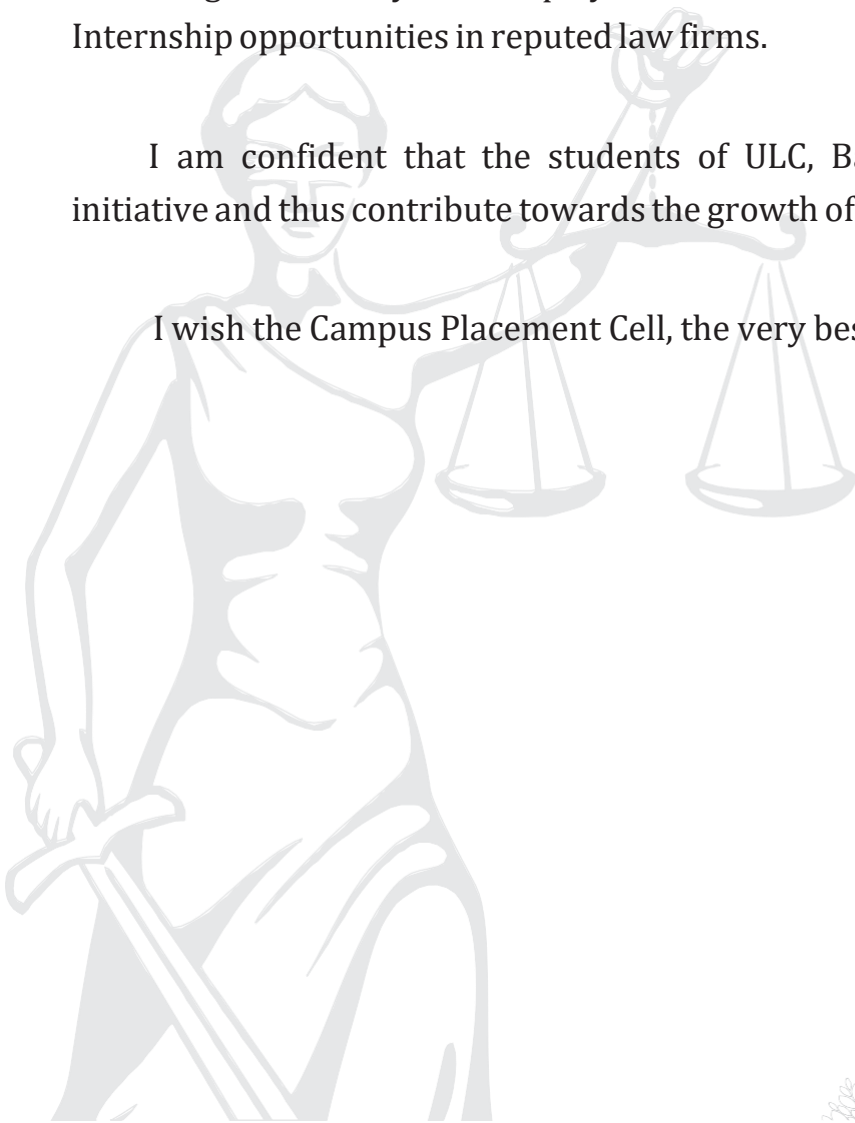

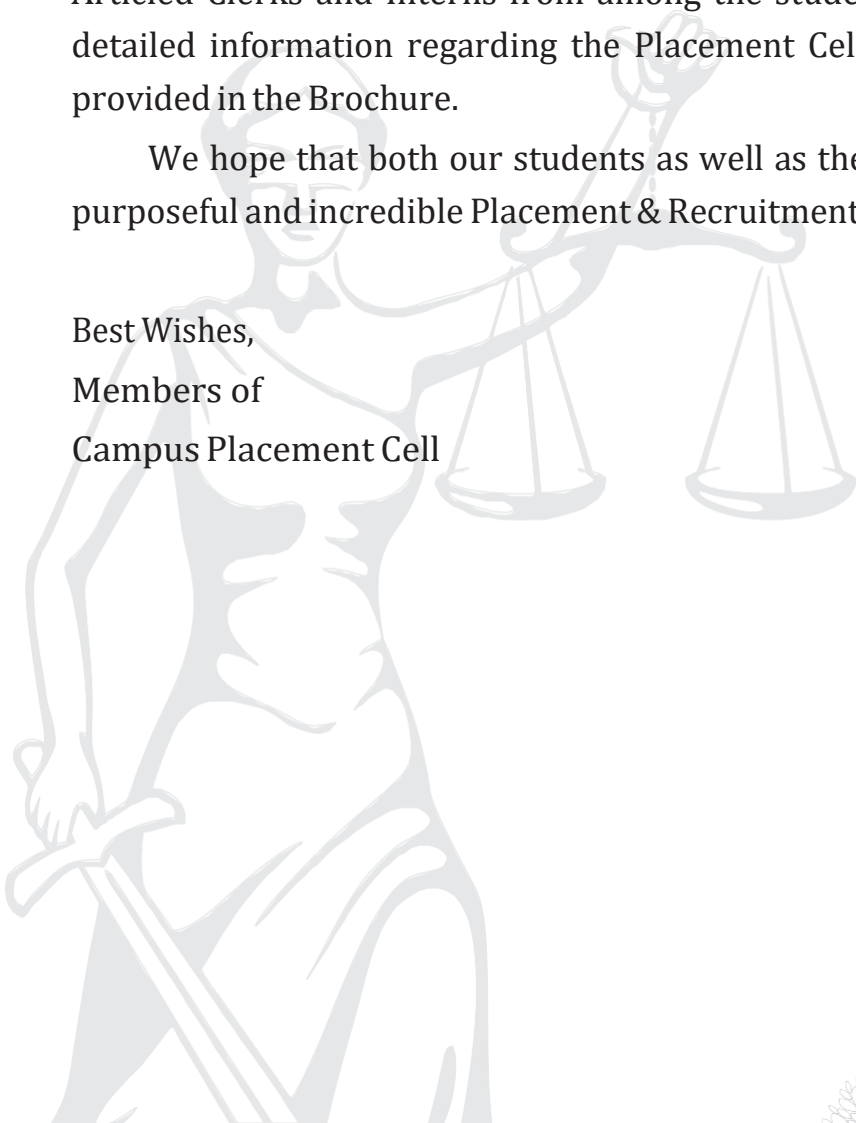

ABOUT ULC, BANGALORE



The University Law College, Bangalore University, is a pioneer legal-education institution located in the garden city of Bengaluru, in the state of Karnataka, India. The college, popularly known as ULC – Bangalore, is widely recognized as one of the country’s best government run law schools.

A challenging curriculum and a diverse student population at ULC prepare the students for success in law practice, litigation, business, public service and teaching. The experience and exposure to various facets of academic and clinical legal training at ULC is unparalleled. Recognizing the necessity of experiential learning, we have developed a state-of- art clinical program offering students an opportunity to be associated with the legal profession through seminars/workshops, internships, mandatory trial-court visits, legal-aid programs, research & projects, model parliament and moot court activities. Legal education at ULC equips the students for the complete spectrum of career opportunities available to lawyers and provides them with the capability to adapt to the rapid pace of change that characterizes modern legal practice. As a testimony to this fact, among ULCs graduates are many Supreme Court and High Court Justices, renowned public servants, bureaucrats, lawyers and academicians of repute.

Vision

To achieve excellence in education for the realization of a vibrant and inclusive society through knowledge creation and dissemination.

Mission

University Law College, Bangalore is committed towards imparting quality education, promoting scientific tempo and blending theoretical knowledge with practical skills. The institution aims at pursuing academic excellence through teaching, research, publications and by providing access to all sections of the society to pursue higher education for promoting leadership qualities among students making them socially sensitive citizens.

Pioneering the 5-Year Integrated B.A.L, LL.B. Program

In the year 1982, Prof. Dr. V.B Coutinho became the Principal of ULC. During his term, the college emphatically transformed into one of the first professional law colleges in the country by introducing the five-year integrated B.A.L,LL.B. program for the first time, in the academic year 1986-87. This was an initiative to achieve higher standards in legal education. A few years thereafter, the Committee on Subordinate Legislation of the 10th Lok Sabha, the Committee of Judges on Legal Education appointed by the Chief Justice of India in 1993, and the All India Law Ministers Conference in 1994 unanimously recommended the adoption of the five year LL.B. program as the course for professional legal education.

Library

The ULC library is enriched with many books, dissertations, Ph. D. thesis, Newspapers, magazines, law journals and other reference material on national and international law. It also provides for online subscriptions like Manupatra, SCC Online, JSTOR, Oxford University Press, Cambridge Press, etc. The library has about 36229 books, 1780 journal back volumes, about 37 current journals, 14 newspapers, 42 magazines, two databases and 18,000 other reference materials.

Student Activities

The student initiative at ULC is its greatest strength and a spirit of collaboration reigns throughout a student's stay at ULC.

Outside the classroom, there are a rich variety of student interest groups which allow students to pursue every possible interest. Although originally students from urban and rural parts of Karnataka looked at ULC to pursue the study of law, today, students come from various regions of the country and several foreign countries as well.

All India Moot Court Competition

The annual national-level Moot Court Competition hosted by ULC is the flagship activity of the student body, the Society of Mooters. The national moot organised by University Law College, Bangalore is one of the oldest and most prestigious moot court competitions in the country. The competition attracts participants from law colleges all across the country. The Judges of the High Court of Karnataka preside over the finals of the Moot Court Competition. This year 25th edition of the competition witnessed 75

registrations out of which 18 teams were shortlisted on the basis of memorial scores. The moot proposition was based on the constitutional complications involved in legalization of same-sex marriage and enforcement of Right to Freedom of Religion.

Legal Aid and Literacy Programme

This is one of the components of the LL.B programme which the ULC puts its heart and soul in its realization. Students of the law programme visit villages and enquire into the deficiencies prevailing in the villages through a scientific questionnaire. This includes the day-to-day problems they face, their level of literacy and the lack of legal knowledge. Through this method the students ascertain the socio-legal problems in these villages. In this programme a group of students assisted by a staff member would provide the necessary advice to tackle their routine legal, social and economic problems. University Law College has been consistently holding this programme since the introduction of the 5 years LL.B programme in the year 1985-86. As a part of the Legal Aid Programme, the college has adopted the village of Kumbalagodu, T. Gollahalli, Bengaluru, Karnataka.

ULC Special Lecture Series

The programme started in 2020 has proved to be very useful for the students to listen and interact with many eminent judges and advocates of the High Court and Supreme Court as the special lectures are periodically organized on legal issues and current relevance. So far more than 40 special lectures have been organized.

Internship, Court and Jail visit

As part of the curriculum, all the students of LL.B. will mandatorily undergo internship programme during the vacations under eminent Judges, Advocates, Bureaucrats, prestigious law firms, companies etc. to hone their skills and get practical exposure. Another component of legal education is court and jail visit. The students of the 4th and 5th year are made to visit courts and the central prison. On appointed days they observe the proceedings of the Court and record their observations in diary for submission. This compulsory exercise provides students first-hand information about the functioning of the Courts and also an insight regarding the application of substantive and procedural laws.

Placement and Internship Cell

The campus placement cell is a student- run body of University Law College, Bengaluru, functioning within the college framework to provide for placements as well as internship opportunities. Companies like L & T, Wipro and HP have been a part of this process.

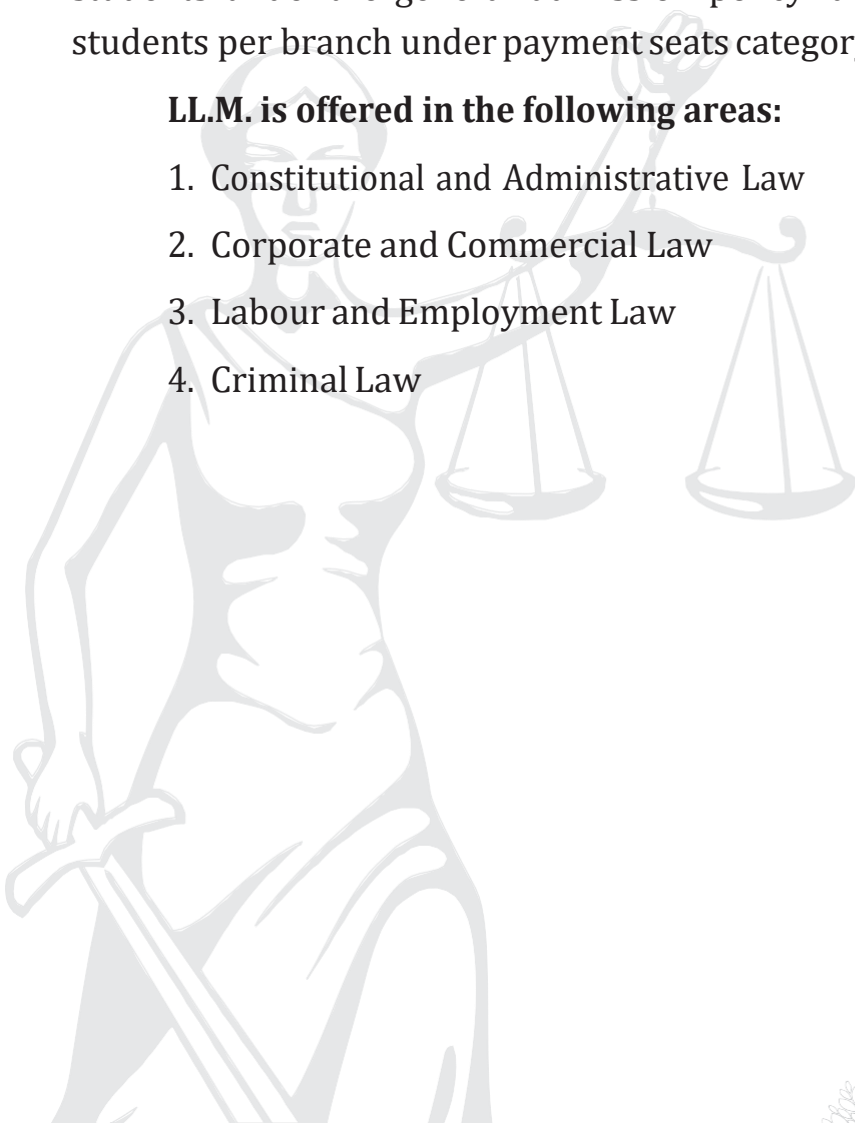

LLM – Master of Laws

The master’s degree in law was started in the year 1960-61 as M.L. Degree course. After becoming part of the Bangalore University in 1976, the P.G. Department of Law has been offering LLM programme in 4 different branches with an intake of 10 students under the general admission policy laid down by the Government and 2 students per branch under payment seats category with enhanced fees.

LL.M. is offered in the following areas:

1. Constitutional and Administrative Law
2. Corporate and Commercial Law
3. Labour and Employment Law
4. Criminal Law



Types of recruitment [the choice of which shall be decided by a discussion of the Campus Placement Cell with the recruiter]

- On campus- shall include the process where even a part of the interview is held in the college. It also includes tests/interviews conducted via video conferencing or through voice call.
- Off campus- firms at liberty to call for interviews outside the campus or to their office.

Guidelines for firms-

- The Recruiters' registration is to be done prior to recruitment.
- The Recruiters can have Induction programmes or other sessions of similar kind to explain the nature of the job or for other similar purposes. [Pre-placement talk]
- The Recruiters are free to stipulate all reasonable eligibility criteria to filter the candidates at the threshold of the recruitment process.
- The Recruiters are required to disclose all the conditions of the vacant job for which the recruitment process is going on. Disclosure at threshold is to be made about the number of vacant positions, salary and other terms of employment. Any additional stipulated conditions is to be informed to the candidate and the College Placement Cell subsequently.
- All communication with the candidate till the end of the recruitment process shall happen through the College Placement Cell.
- Recruiters can have their own structure for the recruitment process which may include group discussions, aptitude tests, interviews and any other method.
- Recruiters are requested to mail or deposit with the Placement Cell, their list of selected candidates along with a list of candidates who have been wait-listed, in order of their preference.
- The selected candidates who feature on more than one Recruiters List will be given the liberty of accepting the offer of their choice. In the event of a selected student not joining a Recruiter, for any reason whatsoever, the candidates on the waiting list will be elevated. This will be done according to the order of preference given by the recruiters. The final decision of the candidates will thereafter be intimated to the Recruiters.

The Campus Placement Cell shall not be responsible for violation of terms by the candidate and the candidate is liable for his own actions.
